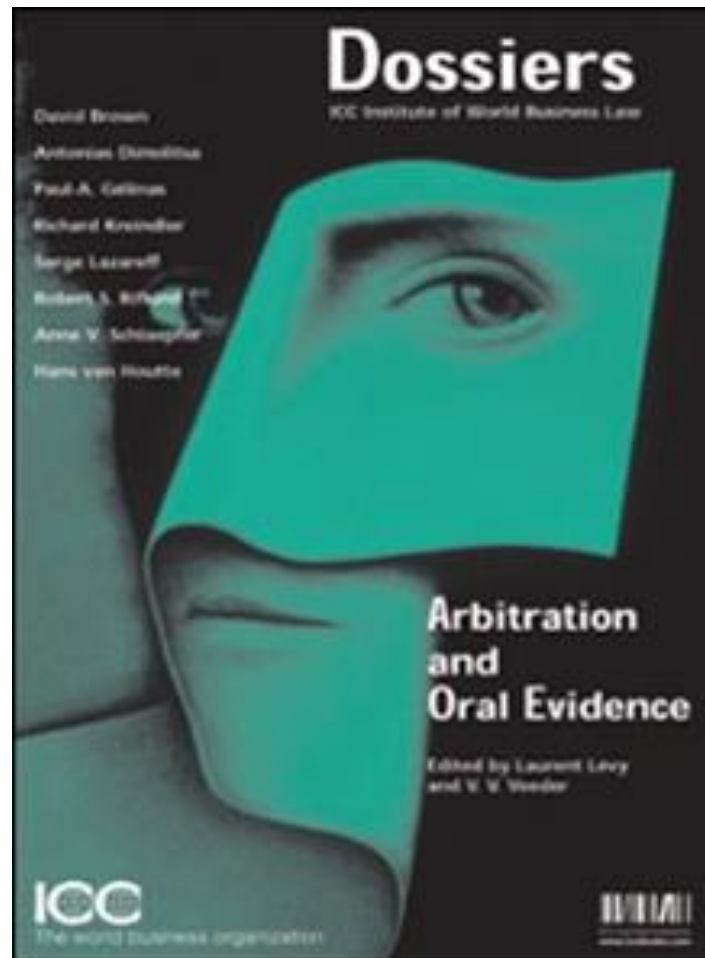

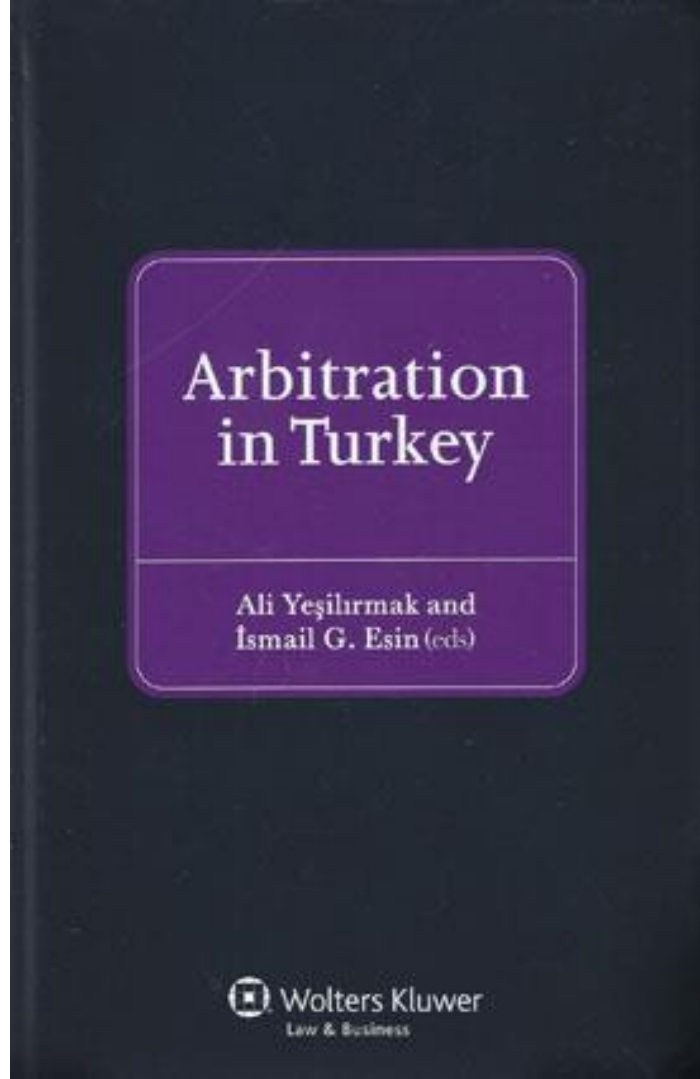

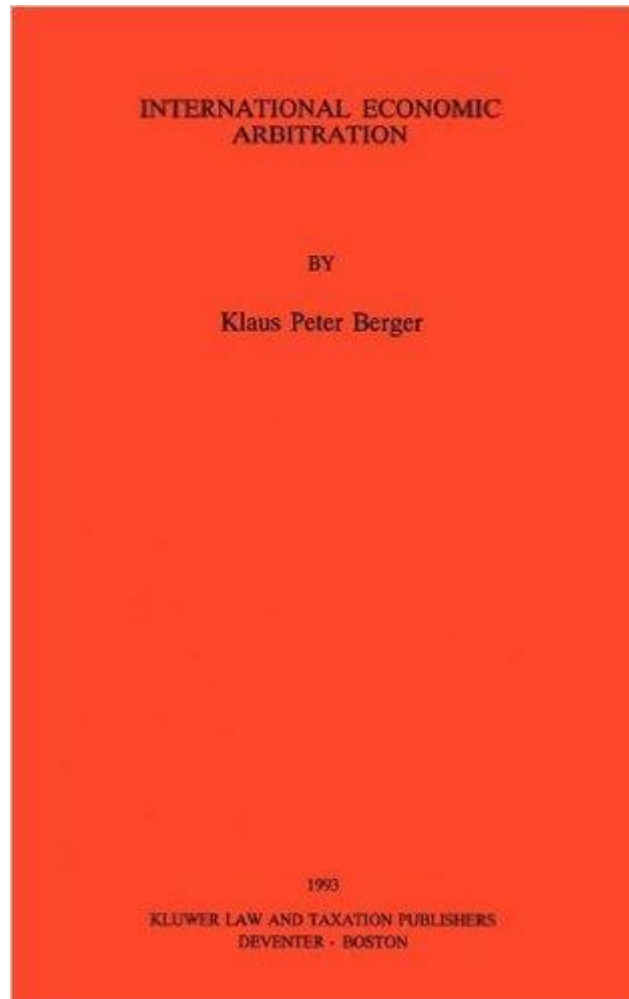

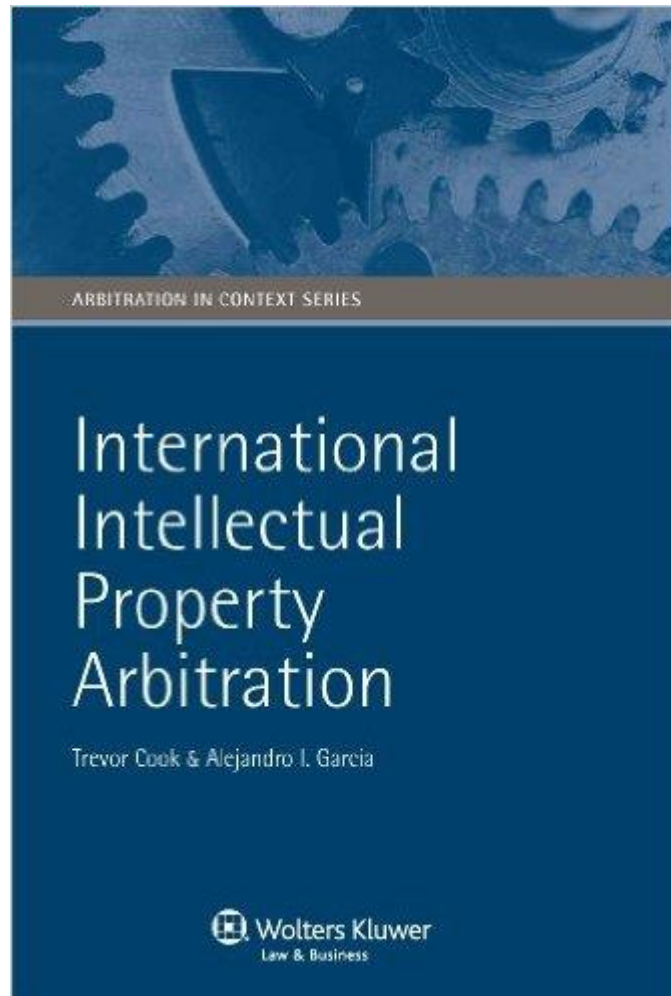

INTERNATIONAL INTELLECTUAL PROPERTY ARBITRATION

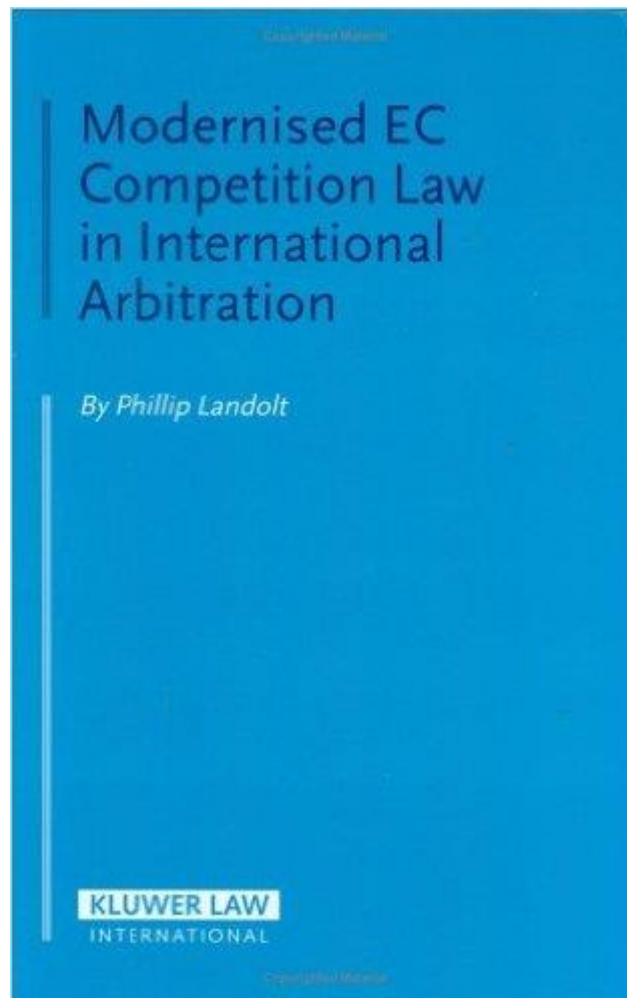

MODERNISED EC COMPETITION LAW IN INTERNATIONAL ARBITRATION

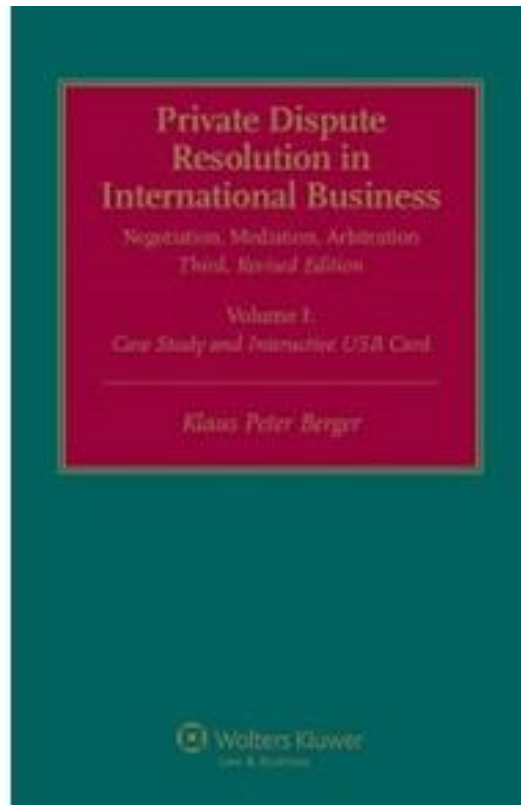
